



INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF VARIOUS INFORMATION AND COMMUNICATIONS TECHNOLOGY (ICT) EQUIPMENT

1. The **MINISTRY OF SOCIAL SERVICES AND DEVELOPMENT BARMM**, intends to apply the sum of **SEVEN MILLION FIVE HUNDRED FIVE THOUSAND AND FIVE HUNDRED PESOS (P7,505,500.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement of Various Information and Communications Technology (ICT) Equipment. The ABC is broken down as follows:

Award of Contract shall be made on a Per Lot basis. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **Ministry of Social Services and Development BARMM** now invites bids for the procurement of the above stated motor vehicles. Delivery of Goods is required **within twenty-five (25) calendar days from receipt of the Notice to Proceed**. Bidders should have completed **within two (2) years** from the date of submission and receipt of bids, a contract similar to this project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders. Bidders may participate for any one or more Lots (Lot 1 to Lot 5).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

In addition, bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from MSSD BARMM and inspect the Bidding Documents at the address given below during Office Hours from 9:00 AM to 4:00 PM (Monday to Friday excluding Holidays).

7. Bids must be duly received by the BAC Secretariat at the address below on or before **June 02, 2020 at 2:30 P.M.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **June 02, 2020 at 3:00 P.M. at the Conference Room, 2nd Floor MSSD BARMM, Bangsamoro Government Center, Rosary Heights VII, Cotabato City**. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Ministry of Social Services and Development reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to

contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


