



Invitation to Bid

Proposed Construction of Three (3) Storey Ministry of Social Services and Development-BARMM Office Building

1. The **Proposed Construction of Three (3) Storey MSSD-BARMM Office Building**, through the Bangsamoro Appropriations Act 2020 intends to apply the sum of *Ten Million Twenty-Nine Thousand Four Hundred Sixty-Eight Pesos (Php10,029,468.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for **Proposed Construction of Three (3) Storey MSSD-BARMM Office Building** located at MSSD BARMM Compound, Bangsamoro Government Center, Cotabato City. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **Ministry of Social Services and Development – BARMM** now invites bids for **Proposed Construction of Three (3) Storey MSSD-BARMM Office Building**. Completion of the Works is required within **300 days** upon receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **Ministry of Social Services and Development – BARMM** and inspect the Bidding Documents at the address given below from **8:00 A.M. to 5:00 P.M.**
5. A complete set of Bidding Documents may be acquired by interested bidders on **September 23, 2020 – October 14, 2020** from the address below **Ministry of Social Services and Development – BARMM, Bangsamoro Government Center, Cotabato City**, pursuant to the latest Guidelines issued by the GPPB.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee in the amount of **Ten Thousand Pesos (Php 10,000.00)** for the Bidding Documents not later than the submission of their bids.

6. The **Ministry of Social Services and Development – BARMM** will hold a Pre-Bid Conference on **October 02, 2020 @ 9:30 AM** at **Conference Room, 2nd Floor Ministry of Social Services and Development – BARMM, Bangsamoro Government Center, Cotabato City**, which shall be open to prospective bidders.

Prospective Bidders may opt to join the Pre-Bid Conference through online video conference using Zoom/Google Meet application.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **October 14, 2020 @ 9:30 A.M.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **October 14, 2020 @ 9:30 A.M.** at **Conference Room, 2nd Floor Ministry of Social Services and Development – BARMM, Bangsamoro Government Center, Cotabato City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **Ministry of Social Services and Development – BARMM** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


