



INVITATION TO BID FOR THE PROCUREMENT OF VARIOUS MEDICAL ASSISTIVE DEVICES

1. The **MINISTRY OF SOCIAL SERVICES AND DEVELOPMENT BARMM**, intends to apply the sum of **FOUR MILLION SEVEN HUNDRED TWENTY THOUSAND PESOS (P4,720,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement of Various Medical Assistive Devices. 2. The **Ministry of Social Services and Development BARMM** now invites bids for the procurement of the above stated motor vehicles. Delivery of Goods is required **within**

twenty-five (25) calendar days from receipt of the Notice to Proceed. Bidders should have completed **within two (2) years** from the date of submission and receipt of bids, a contract similar to this project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders. Bidders may participate for any one or more Lots (Lot 1 to Lot 4).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

In addition, bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- Bid opening shall be on **October 12, 2020 at 2:30 P.M. at the Conference Room, 2nd Floor MSSD BARMM, Bangsamoro Government Center, Rosary Heights VII, Cotabato City.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
