



INVITATION TO BID

FOR THE

SUPPLY AND DELIVERY OF VARIOUS FOOD ITEMS FOR SUPPLEMENTARY FEEDING PROGRAM FOR FY 2020

1. The **MINISTRY OF SOCIAL SERVICES AND DEVELOPMENT BARMM**, intends to apply the sum of **ONE HUNDRED FORTY-FIVE MILLION ONE HUNDRED FORTY-EIGHT THOUSAND FOUR HUNDRED PESOS (Php 145,148,400.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement of Various Food Items. The **Ministry of Social Services and Development BARMM**, through the **Bids and Awards Committee (BAC)**, now invites bids for the goods and services contemplated in this project and as detailed in the Schedule of Requirements and the table of Technical Specifications indicated in the bidding documents. **Expected completion of delivery of the goods is within twenty-five (25) calendar days upon receipt of Notice to Proceed (NTP).**

Prospective bidders should have completed, within **ten (10) years** immediately preceding the deadline for the submission of bids, Single Largest Completed Contract (SLCC) similar to the contract to be bid and the value of which, adjusted, if necessary, by the Bidder to current prices using the Philippine Statistics Authority (PSA) consumer price index, must be at least fifty percent (50%) of the ABC of the lot bid for; OR, at least two (2) similar contracts and the total of the aggregated contract amount should be equivalent to at least fifty percent (50%) of the ABC of the lot bid for; and the largest of these similar contracts must be equivalent to at least twenty-five

percent (25%) of the ABC of the lot/s to be bid. The contracts may come from different agencies/companies.

The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders. Bidders may participate for any one or more Lots (Lot 1 to Lot 14).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **January 19, 2021 at 9:30 A.M.** at the **Conference Room, 2nd Floor MSSD BARMM, Bangsamoro Government Center, Rosary Heights VII, Cotabato City**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

Interested Bidders shall submit valid original and one (1) certified photocopy of the Special Power of Attorney for the representative, if sole proprietorship / partnership business and/or Board Resolution or Secretary's Certificate if corporation/cooperative which shall be limited to employee or immediate members of the family and official/officer/employee of the corporation.

The **Ministry of Social Services and Development BARMM** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
